INVESTMENT STRATEGY

The Tweedy, Browne Worldwide High Dividend Yield Value Fund invests primarily in both US and foreign equity securities that the Investment Adviser believes to have above-average dividend yields and valuations that are reasonable.

COMMITMENT OF THE ADVISER

As of September 30, 2025, the current Managing Directors and retired principals and their families, as well as employees of Tweedy, Browne, had more than \$319.7 million invested in our Funds, including approximately \$7.5 million in the Worldwide High Dividend Yield Value Fund. Investment Committee members have spent between 8 to 50 years working at Tweedy, Browne. No Management Committee member has ever left the firm except for the reason of retirement.
